The Representatives of the Enforcement Funding Scheme explained to Council how it would work and that they were still conducting a Survey of how many Town / Community Councils would wish to participate in the Scheme. C Clrs Wisinger and Connah enquired if a portion of the costs paid (£195/day)could be refunded? Although this question would require further investigation, it would seem that costs would cover an additional officer and administrative services.

Council expressed interest, and Cclr Mrs P Connah would send an e mail of the area 'hot spots' to renforcemenr. No final decision was made, pending the results of the further enquiries.

Watkin Street sign needed needed straightening and gully grate by Scout Hut in Sandycroft needed clearing of vegetation. John Griffiths would obtain a quotation for the clearing of vegetation in Fairfield Road Queensferry rear access.

b) General Issues :- 9 replacement street lights were n order to be erected in Hamilton Avenue , to be subsequently adopted by Flintshire C.C.
