Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2022 of:

Auditor General's report

Audit opinion – Qualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year:

- Assertion 1 – effective financial management. The Council's internal auditor states that the Council has not routinely monitored expenditure against the agreed budget.
- Assertion 2 – maintenance of an adequate system of internal control. The Council has not adopted or reviewed its standing orders and financial regulations based on the One Voice Wales/NALC model nor are they included on the Council's website. We recommend that the Council reviews and formally adopts new standing orders and financial regulations in accordance with One Voice Wales guidance.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Council Approval Arrangements

The Council approved the annual return prior to receiving assurance from the internal auditors. We recommend that the Council receives, accepts and consider any findings from the internal auditor prior to signing and approving the annual return.
